 An assessment of the range of risks to the continuation of study for your students, how those risks may differ based on your students' needs, characteristics and circumstances, and the likelihood that those risks will crystallise.

Risk Assessment and Contingency Planning for Continuation of Study Petroc, in partnership with the University of Plymouth, ensures the quality of the student experience through the Academic Cooperation Agreement. However, unforeseen circumstances may necessitate changes to modules, programmes, or locations. This Student Protection Plan is reviewed annually and made available on the college website. It outlines potential risks to programme delivery, and the steps Petroc will take to mitigate them, ensuring minimal disruption to students.

Communication and Student Support

Petroc is committed to keeping students informed of any changes and providing options to minimise disruption, including:

- Transferring to another programme
- Offering modified programmes
- Assisting with transfer to a different provider
- Teaching at a different location
- Offering refunds or compensation as outlined in the Refund and Compensation Policy



Petroc will provide detailed guidance and support if programme transfers are required, including advice on student finance implications.

Key Risks and Mitigation

The Higher Education and Research Act 2017 mandates that Petroc outlines steps to protect students in the event of significant changes, such as:

- Programme disruption
- Industrial action
- Departure of key staff
- Programme cessation
- Major changes to programme content
- Suspension or revocation of P's Tier 4 sponsor licence
- Changes to regulatory frameworks of loss of accreditation
- Campus closure
- Loss of qualification-awarding powers

Minimising Disruption

Petroc will take the following actions to mitigate disruption:

- Adjusting delivery location or methods, such as using blended learning
- Recruiting new staff to ensure continuity
- Assisting students with programme transfers or access to alternative providers
- Teaching out cohorts where a programme is discontinued, ensuring students can complete their studies

In cases of staff unavailability due to sickness, retirement, or departure, Petroc will aim to reassign responsibilities or recruit externally to avoid disruption. In the case of industrial action, Petroc will work with trade unions to minimise impact on students and may use blended learning to maintain operations.



Programme Changes

Petroc strives to deliver programmes as described on the website and prospectus. If significant in year changes are necessary, Petroc will:

- Minimise changes and notify students in advance
- Consult with affected students
- Offer support for transferring to alternative programmes

Other Circumstances

In rare cases of programme cessation or mode changes, Petroc will aim to teach out the programme or assist students in transferring to another provider. If Tier 4 Sponsor status is affected, Petroc will work with UKVI to minimise disruption. If the University of Plymouth revokes the academic cooperation agreement, Petroc will aim to teach out existing cohorts, ensuring minimal impact. Should a campus close, teaching may be relocated or delivered through alternative modes such as blended learning.

Conclusion

This plan, reviewed annually, ensures that Petroc remains committed to supporting students through unforeseen circumstances. The Refund and Compensation Policy will apply if students cannot reasonably continue their studies.
